# Season Highlights

Our 84th season began with the most famous four notes in music – Beethoven's powerful *Fifth Symphony.* In a season that celebrated the return of live, inperson concerts at our home in the Civic Center, it seemed only fitting to include Beethoven's joyful *Ninth Symphony* in April. The Orchestra performed

Beethoven's timeless masterworks along with new classics from contemporary composers George Walker, Anna Clyne, Dobrinka Tabakova and Jessie Montgomery. The 2021-2022 season concluded with the romantic thrill of Tchaikovsky's *First Piano Concerto* and the splendor of *Pictures at an Exhibition*.

Des Moines Symphony Academy faculty provided top-quality music education in a safe learning environment, and after a long hiatus, our Youth Orchestras program resumed in the fall with five student ensembles. In the winter, the addition of a Jazz Orchestra to the roster of ensembles created a new way for


students to enjoy and appreciate instrumental music.

For the first time since 2019. the Des Moines Symphony and thousands of Central Iowa music lovers gathered on the State Capitol grounds for our 28th Yankee Doodle Pops complete with patriotic favorites, live cannons, and a fireworks finale over the Des Moines skyline. On Labor Day weekend, audiences again enjoyed two free outdoor concerts in our third season of Water Works Pops in the Lauridsen Amphitheater at Water Works Park, supported by the generosity of Linda & Tom Koehn. The Sound of the City Campaign came to a close and surpassed the \$7 million campaign goal. Our sincerest thanks to the nearly one hundred donors who supported the campaign. Paired with the generous donations made to the Annual Fund each year, these gifts will allow us to continue to create extraordinary live musical experiences and outstanding educational programs for years to come. Thank you for ensuring the sound of our city lives on.

## **DONOR SUPPORT**

The Des Moines Symphony & Academy received \$1,341,031 from individual donors and grants from government, corporate and foundation sources; this represents 28% of 2021-2022 revenue.

## EARNED REVENUE

Earned revenue from ticket sales, performance fees, and Symphony Academy tuition totaled \$1,066,051 or 23% of total revenue.

## **COVID RELIEF**

In 2021-2022 Des Moines Symphony & Academy received funding associated with two national COVID-19 relief measures — a forgivable Ioan from the Paycheck Protection Program and a Shuttered Venue Operator Grant. The Small Business Association administered both programs.


## DES MOINES SYMPHONY FOUNDATION

Des Moines Symphony Foundation is a nonprofit organized to provide a base of financial support for the Symphony & Academy through the prudent investment of donor gifts. An independent board of directors governs the Foundation and annually approves the distribution of funds. In 2021-2022 the distribution from the Foundation was \$961,463.

## **EXPENSES**

In 2021-2022, 76% of the expenses of the Des Moines Symphony & Academy were dedicated to programs, including all concerts and Academy programs. Fundraising accounted for 6% of expenses, including development staff and systems. Administrative costs were 17% percent of total 2021-2022 expenses and includes back-end functions such as accounting.
